Pursuant to 20-9-328, MCA
Fund & Revenue Code: 01-3112

The at-risk student payment is a component of the General Fund BASE budget of the district. The payment must be distributed to public school districts by the office of public instruction in the same manner that the office of public instruction allocates the funds received under 20 U.S.C. 6332, et seq. The office of public instruction shall prorate payments to districts based upon the available appropriation.

The available appropriation is distributed in the same manner as Federal Title I monies.
